For your information, a hearing was held at U.S. District Court yesterday on my related motion to bring the Angle Decree court, the water master and the Decree into alignment and simplify the issues for you. The judge will be ordering me to bring the motion in a different form, but indicated he would prefer you resolve your end of the issues first. Since you are a party to the Angle Decree as an *in rem* and *in personam* successor and assign, the appropriate way to handle much of this is for the Water Master and Department of Justice to bring you before the U.S. District Court in a contempt proceeding of some sort, but that seems unlikely until the alignment I sought occurs.
